

## UST Operator Training

The PSTIF Board of Trustees held a public hearing on March 14, 2012 in Jefferson City to hear testimony from interested persons on whether to create and fund an underground storage tank operator training program.

At the hearing, Carolyn Hoskinson, Director of EPA's Office of Underground Storage Tanks, explained the federal requirements and answered questions from Trustees. The MO Department of Natural Resources urged the Board to create a program, and Wallis Companies offered ideas on how to make it less burdensome for tank owners and operators.

Additional comments are welcome. The Board plans to make a decision at its meeting on July 25.

## Proposed New EPA Rules for USTs

The U.S. EPA extended its deadline to comment on proposed new rules governing the operation of USTs to April 16, 2012.

## Legislative Report

Several bills of interest are being considered by the Missouri Legislature, which is in session until May 18:

**"Fund Sweep,"** SB899—Would transfer cash from special state funds into general revenue; is unclear whether the bill would affect the PSTIF, as it contains certain exemptions.

**"Downsizing Government,"** SB469 & HB1135—Would require all state agencies to periodically review all their rules and determine whether rules should be rescinded or amended to be less onerous.

**"State Program Reviews,"** HB1029—Requires evaluation of state agencies, including budget transparency and accountability, by the Legislature's Oversight Committee.

**"Retailer Liability,"** SB491—Protects retailers who sell ethanol-blended fuels from liability under state law for damage to customers' vehicles.

Other bills would alter Missouri's tort laws, affect gubernatorial appointments to boards and commissions, and change Missouri's Sunshine Law.
