## EPA, DNR, and PSTIF all agree . . .

. . . The pace of tank site cleanups in Missouri is too slow.

In the first decade of Missouri's tanks program, (~1991-2000), approximately 3700 confirmed petroleum releases were cleaned up and received the coveted "No Further Action Letter."

In the second decade, (2001-2010), only about 1720 NFAs were issued for confirmed releases.

At the current rate, fewer than 1300 cleanups will be completed in the third decade.
